### **Application Procedure**

## I: Applicant Eligibility

- 1. Eligible applicants must meet MOE's *Regulations Regarding International Students Undertaking Studies in Taiwan* (For regulations, please see Appendix on p.15)
- 2. Eligibility criteria for the above-mentioned application:

- For admission to Bachelor Programs: High school diploma.
- **2** For admission to Master's Programs: Bachelor's degree.
- 3 For admission to Doctoral Programs: Master's degree
- 3. Applicants may use the "International Student Status Eligibility Check" to determine their eligibility to apply and learn the proper admissions procedure: https://bds.oia.ntnu.edu.tw/bds/apply

\*Due to varying educational systems worldwide, applicants who graduate in the same year of their admissions to National Taiwan Normal University should ensure that they receive their diploma and academic transcript by the deadline specified for the chosen semester (applicants applying with diplomas or degree certificates from Mainland China are required to have the documents notarized by the relevant authorities). Applicants must meet the above requirement to be eligible to apply. Fall 2024: August 31, 2024 Spring 2025: January 31, 2025

\*Foreign students who are enrolled in a senior high school in Taiwan must meet the requirements for high school diplomas as stated in Article 8, Paragraph 2 of MOE's *Regulations Regarding International Students Undertaking Studies in Taiwan* and hold the necessary documentation in order to apply to NTNU through this admissions track.

### Note 1

According to Article 2 of the *Nationality Law*, a person who meets one of the following requirements has Republic of China nationality:

**①**A person whose father or mother was, at the time of his/her birth, a citizen of the Republic of China.\*

A person born after the death of his/her father or mother, and whose parent was, at the time of death, a citizen of the Republic of China.\*

③A person born in the territory of the Republic of China and whose parents are both unknown or are stateless.④A naturalized citizen.

\* An individual born on or before February 9, 1980 only need to consider the nationality of his or her father.

#### Note 2

 As stated in *Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan*, "Overseas Chinese students who have graduated, been expelled, or been suspended from their studies for longer than the maximum allowable duration will lose their status as an overseas Chinese student (...) Students whose status has been temporarily suspended will resume their status upon returning to school." Anyone meeting one of the following requirements will be considered as an overseas Chinese, and is therefore disqualified from applying as an international student:

Having previously studied at the Division of Preparatory Programs for Overseas Chinese Students at National Taiwan Normal University (formerly known as National University of Preparatory School for Overseas Chinese Students).
 Having applied for studies or previously studied in any school in Taiwan as an overseas Chinese.

Having taken the university entrance exam for overseas Chinese students held by the University Entrance Committee for Overseas Chinese Students and who has filled out preferences for a university/college and has been admitted to one of those universities/colleges.

## IV: Application

### **1.Time period:**

2024 Fall Semester: October 2, 2023 - January 17, 2024 \*

2025 Spring Semester: June 3, 2024 - July 31, 2024

\* The application deadline for the Graduate Institute of International Human Resource Development is March 15, 2024.

### 2. Application submission

- Please apply online via our application website: https://bds.oia.ntnu.edu.tw/bds/apply. Only online applications shall be accepted. Please fill out the online application and upload all documents before the stated deadline. Hard copy applications/documents will not be accepted.
- 2 Applicants applying for two programs or more, or applying for different divisions of the same department/graduate institute, should submit their applications separately to each department/graduate institute or each division.

### 3.Fees and payment

• Fees: A separate registration fee is required for each application to a department/graduate institute or academic division. Please ensure your non-refundable application fee has been paid ahead of the application deadline in order to be eligible for the following semester.

Bachelor Program admission -- NT\$1,200 (US\$50)

Master's Program admission -- NT\$1,500 (US\$60)

Doctoral Program admission -- NT\$3,000 (US\$120)

\*If the applicant is of foreign nationality as specified in Article 2 under MOE's *Regulations Regarding International Students Undertaking Studies in Taiwan* (Appendix) and has (or had) R.O.C. nationality, additional proof is required. Proof can be entry and departure records for the past six years, a declaration form stating that the applicant does not hold an R.O.C. household registration (see Attachment III, p.30), Certificate of Nationality Renouncement of Republic of China or other documentation.

- A copy of the applicant's highest-level diploma in Chinese or translated into English. If a diploma is not in Chinese or English, a Chinese or English translation of the diploma shall be required. (Admitted students must submit their original diploma for review to the Office of International Affairs on the day of enrollment.) Applicants applying with diplomas or degree certificates from Mainland China are required to have the documents notarized by the relevant authorities.
- A copy of the applicant's complete transcripts (for ALL years of study) in Chinese or translated into English. If the transcripts are not in Chinese or English, a Chinese or English translation of the transcripts shall be required. (Admitted students must submit their original transcripts for review to the Office of International Affairs on the day of enrollment.) Applicants applying with diplomas or degree certificates from Mainland China are required to have the documents notarized by the relevant authorities.
  - \*Applicants applying with diplomas or degree certificates from Mainland China are required to have the documents notarized by the relevant authorities. If authentication cannot be completed by the application deadline, please submit the degree certificate, complete transcript, and signed Deposition of Admission Documents (see Attachment IV, p.31).
  - \*Eligible applicants who graduate in the same year of their admission to National Taiwan Normal University must submit transcripts for each academic semester, the enrollment certificate or the letter/proof of expected graduation, and the Deposition of Admission Documents (see Attachment IV, p.31). They shall not be required to submit their diploma during the application process. However, their diploma and transcripts for each academic semester must be submitted upon registration at NTNU (diplomas or degree certificates from Mainland China are required to be notarized by the relevant authorities), otherwise their admission to NTNU will be revoked.
  - \*NTNU holds the right to require applicants to have their degree certificate or diploma authenticated by the R.O.C. diplomatic missions should NTNU find any problem in the applicants' documents.
- ③A financial statement: a minimum of NTD 150,000 (or USD 5,000) is required. Please select one of the following ways of submission:
- ()An official financial statement issued within the past three months from a financial institution.
- (2) If the financial statement provided is not under the name of the applicant, please submit: 1. The guarantor's financial statement; 2. A financial guarantee statement from the guarantor (see Attachment V, p.32).
- ③Proof that the applicant has been awarded full scholarship.

- Language proficiency requirements: applicants applying for program taught in Chinese should submit a Chinese proficiency certificate; those applying for program taught in English ((including English-taught programs and programs with enough English courses to meet graduation requirements) should submit an English proficiency certificate. For the language proficiency level required by specific departments/institutes, please refer to the information on the application website: https://bds.oia.ntnu.edu.tw/bds/apply

### 5.Miscellaneous

- This admission prospectus operates under MOE's Regulations Regarding International Students Undertaking Studies in Taiwan. Documents and relevant regulations will be subject to the most recent version of MOE's Regulations Regarding International Students Undertaking Studies in Taiwan.
- 2 International students admitted to NTNU will have their admissions revoked and shall be dismissed from NTNU in the following cases:
  - ①Violation of MOE's Regulations Regarding International Students Undertaking Studies in Taiwan.
- ②Any NTNU student who is currently studying (including those who have suspended their studies) or whose admission status is extended may not apply for admission to the same program of study in the same department/ graduate institute. In verified cases, the international student will have their admissions revoked, and the vacancy thus created will be filled in the order of the names as they appear on the waitlist.
- ③Applicants must take any written exams, interviews, and/or technical tests required by the department or graduate institute to which they are applying. A passport or other form of picture identification must be presented at the test site.
- 4 Students who have completed the application process are not allowed to request a program change.

Incomplete applications may be deemed as invalid. In such cases, applicants must bear full responsibility.

- OPlease ensure that the email address and contact phone number provided in the application system are correct. Applicants may be contacted as needed. Failing to respond within the specified deadline may result in students forfeiting their rights and privileges.
- High school graduates whose qualifications are equivalent to Grade 5 of Taiwan's high-school system may apply for undergraduate programs. However, admitted students shall complete at least 12 more credits before graduation in accordance with the relevant NTNU rules and regulations.
- Students should possess basic skills in Chinese or English. When required by the relevant department or graduate institute, applicants should submit proof of proficiency certificates such as Chinese or English language certificates. Regarding Chinese language proficiency, applicants shall take a Test of Chinese as a Foreign Language (TOCFL, administered by the Steering Committee for the Test of Proficiency-Huayu). For the test schedule, registration periods, and additional details of TOCFL, please visit the following website: https://tocfl.edu.tw/
- If admitted students are having difficulties in catching up with class due to inadequate Chinese language proficiency, they shall be required by their department/graduate institute to take extra Chinese language courses as needed, and the students shall be required to pay for the extra courses themselves. In addition, students admitted to NTNU must fulfill the language requirement set by their department/graduate institute as part of its graduation requirements.
- OStudents admitted to bachelor programs must take and pass the course "Basic Service Learning" as part of their graduation requirement.
- If application materials are found, at any time, to contain inaccurate, false, or fraudulent information, inauthentic documents, or fail to meet admission requirements, the student in question shall have his/her admission to NTNU revoked and be dismissed from the University. Students who have already graduated will have their diploma revoked.

## V: Rules Governing Admission

- 1. The final list of admitted students will be decided by the Admissions Committee. A number of candidates may be put on a waiting list in case any admitted students fail to complete registration procedures.
- 2.Individual departments/graduate institutes may choose not to admit their full quota of students. In such cases, no waitlisted candidates will be admitted.

## VI: Admission Announcements and Online Confirmation

- 1. The dates for the release of admission results of each admissions period will be announced on the following website: https://bds.oia.ntnu.edu.tw/bds/apply
- 2.Following their application submission, prospective students should log onto the following website to check for admission results: https://bds.oia.ntnu.edu.tw/bds/apply
- 3. Admitted students will receive notification through registered mail.
- 4.Admitted students are required to complete the online registration before the stated deadline at: https://bds.oia.ntnu. edu.tw/bds/apply. Students failing to complete the online New Student Confirmation Form will be regarded as having voluntarily forfeited their admission status. Vacancies resulting from students who have forfeited their admission will be filled in the order of the names as they appear on the waitlist.
- 5.Students hoping to retain their name on the waitlist must complete an online confirmation procedure before the specific deadline as outlined in the notification letter; otherwise, students shall forfeit their place on the waitlist. Waitlisted students who are admitted to NTNU will receive an additional notification letter and shall be required to complete relevant registration procedures before the closing date for registration, which is the first day of class of the current academic year as specified by the annual school calendar. Students who fail to register by this date will be seen as having forfeited their admission to NTNU.

## VII: Registration

1.Admitted students who have completed the online New Student Confirmation Form must complete all registration and enrollment procedures before the class sign-up deadline, including applications for admissions deferral or the suspension of studies to avoid having their admission status revoked in accordance with the Admission notification

- regulations for confirmation and registry procedures. Those applying with diplomas or degree certificates from Mainland China and who have not had their documents notarized by the relevant authorities by the application deadline shall present the notarized documents to the Office of International Affairs within one month from the day of when admission results are announced. Otherwise, their admissions status will be revoked. Applicants graduating at the end of the current academic year must have their documents reviewed by the Office of International Affairs before registration or their admission status will be revoked.
- 2.According to MOE's *Regulations Regarding International Students Undertaking Studies in Taiwan*, upon enrollment admitted students must provide proof of medical and personal accidental insurance from their home country valid from the date they enter the R.O.C. and up to at least six months or purchase six-month-long medical and accidental insurance coverage through NTNU. Students already insured by the R.O.C.'s national health insurance must also provide proof of insurance. If the proof of insurance is issued outside of Taiwan, it should be verified by R.O.C. diplomatic missions in the country where the document was issued.
- 3.Admitted students who are unable to register by the registration deadline and would like to extend their admission status to the following academic year must apply for an extension with the Division of Registry, Division of Graduate Studies under the Office of Academic Affairs at the main campus, or the Division of Academic Affairs for Gongguan Campus before the first day of class of the original semester in which the student was to commence their studies. Please note that not all departments/graduate institutes allow the extension of admission status. (Please refer to respective remarks of the department/graduate institute at: https://bds.oia.ntnu.edu.tw/bds/apply) Students whose application for admission status extension are approved by the University may begin procedures for entering the University the following academic year in accordance with the rules and regulations that apply to all new students for that year.
- 4.When required by their department/graduate institute, admitted students must register with the Steering Committee for the Test of Proficiency-Huayu to take a Test of Chinese as a Foreign Language (TOCFL). Students shall be required to pay for the test themselves. Please visit the following website for registration periods and additional details: https://tocfl.edu.tw/
- 5. Transferring credits from other colleges/universities will be governed by the related regulations of this University.
- 6.Admitted students should inquire at R.O.C. overseas missions to see if a language proficiency test certificate is required for visa application. A lack of required documents may lead to a failure in obtaining a visa for your study at NTNU.
- 7.Obtaining admission to NTNU does not guarantee the issuance of a Resident Visa. Obtaining a Resident Visa does not entitle the visa holder to enter the R.O.C. (Taiwan). Visa issuance is an act of sovereignty. According to the *Statute Governing Issuance of R.O.C. Visas in Foreign Passports* and *Enforcement Rules for the Issuance of R.O.C. Visas to Foreign-Passport Holders*, the R.O.C. reserves the right not to issue a visa and is under no obligation to disclose the reason. If there is any problem related to visa issuance, admitted students should inquire at their R.O.C. overseas diplomatic mission.

## VIII: Miscellaneous

- 1.For admission results appeals, problems of admission procedures or possible gender inequality, applicants may submit a written statement to the Office of International Affairs within 15 days of admission notification. Anonymous appeals shall not be processed.
- 2. Issues not covered in these guidelines are either prescribed in *Admission Regulations for International Students of NTNU* or left to the discretion of the NTNU Admissions Committee.
- 3.In the event of discrepancies between the Chinese version and the English version of this Prospectus, the Chinese version shall prevail.

# MOE Regulations Regarding International Students Undertaking Studies in Taiwan

\* Notes: In the event of discrepancies between the Chinese version and the English version of this Regulation, the Chinese version shall prevail.

Article 1	These Regulations are formulated in accordance with the provisions of Article 25, Paragraph 3 of the University Act, Article 32, Paragraph 1 of the Junior College Act, Article 41, Paragraph 1 of the Senior High School Education Act, and Article 6, Paragraph 3 of the Primary and Junior High School Act.
Article 2	A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations: 1. The person has never undertaken studies in Taiwan as an overseas Chinese student.
	2. The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan. A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six
	years is also permitted to apply for admission to an educational institution, in accordance with these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years. 1. A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.
	<ol> <li>A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application.</li> <li>A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.</li> </ol>
	A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval.
	The periods of six years and eight years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.
	The term "overseas" used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term "reside overseas continuously" means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating
	the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:
	<ol> <li>attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;</li> </ol>

However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.
	The term "resided [] continuously" in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period of continuous residence referred to in the previous paragraph.
	A person who was formerly from the Mainland Area and who has foreign nationality and has have never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution, in accordance with the provisions of these Regulations. In due course each university and tertiary college shall also verify whether any commissioned party has collected any unreasonable fees from international students, established any loan relationship with any international student, or whether any other violation of related ordinances has occurred, and when necessary, it may check details with international student(s who are applying for admission. When a university or tertiary college handles matters related to the admission of international students itself or it commissions an external institution, legal person, group, or individual to do so, it is not permitted to provide any information that is inconsistent with its admission, admission

The admission notice referred to in Paragraph 1 shall set out in detail in both Chinese and English the name of the international student, the name of their program of study, the degree level, the language of instruction, the academic year of enrollment, the date the semester begins, the tuition and miscellaneous fee collection and refund criteria, any scholarship or grant awarded to the student, and any other pertinent information that international students must be notified of, and verify that international students studying in Taiwan understand their associated rights and obligations. A university or tertiary college institution may provide versions of these details in other mother languages of its international students.

Academic credentials issued by a campus or branch of a foreign educational institution which it has established in the Mainland Area shall be notarized by a notary public office there and authenticated by an authority established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan. 3. Proof of applicant's having sufficient funds to live on while studying in Taiwan. 4. Documentary evidence of the eligibility of a guardian in Taiwan. 5. A power of attorney from the student's parents or other legal representative, which has been authenticated by an overseas mission, appointing the guardian in Taiwan. 6. A letter of agreement from the guardian in Taiwan which has been notarized by a notary public in Taiwan. 7. Any other documents required by the school, college, or university. The academic credentials stipulated in Subparagraph 2 of the preceding paragraph are not required to be submitted for an application to be admitted for the first semester of the first grade of elementary school. Adult international students are not required to submit the documents stipulated in Paragraph 1, Subparagraphs 4 to 6. When a junior college, or school is reviewing an international student's admission application, if any of the documents specified in Paragraph 1, Subparagraphs 2, 3, and 7 have not been authenticated by an overseas mission, or by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan, and the junior college or school has any doubts about them, it may request authentication by an overseas agency. If documents that have already been authenticated raise any doubts, the junior college or school may request examination of the documents. Article 19 The guardian in Taiwan referred to in the preceding article shall be an R.O.C. citizen who has household registration in Taiwan and shall submit a Police Criminal Record Certificate, and an income tax inventory for the most recent year checked and issued by a taxation organization itemizing personal taxable income from all sources of at least TWD 900,000. A person who satisfies the requirements prescribed in the preceding paragraph may serve as the guardian in Taiwan of only one international student. Academic credentials issued by a campus or branch of a foreign educational institution which it has established in the Mainland Area shall be notarized by a notary public office there and authenticated by an authority established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan. The academic credentials stipulated in Subparagraph 3 of the preceding paragraph are not required for an application for admission to the first semester of first grade at an elementary school. When a junior college, or school is reviewing an international student's admission application, if any of the documents specified in Paragraph 1, Subparagraph 3 have not been authenticated by an overseas mission, or by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan, and the junior college or school has any doubts about them, it may request authentication by an overseas agency. If documents that have already been authenticated raise any doubts, the junior college or school may request examination of the documents After the admission of the international students referred to in Paragraph 1, a senior secondary school, junior high school, or an elementary school shall submit a list of their details to the competent education administrative authority for future reference. If a senior secondary school, junior high school, or an elementary school cannot admit the international student referred to in Paragraph 1 applying to study there because the school has already filled its admission quota, the student may apply to the competent education administrative authority for a transfer to be admitted to a school that has a vacancy. A senior secondary school, junior high school, or an elementary school may assign the international student referred to in Paragraph 1 applying to study there to an appropriate grade level or give them a 'provisional' admission status, based on their results during the screening process. This 'provisional' status is valid for up to one year, and their student registration shall be confirmed if they pass the examinations. Article 20-1 If a chaotic war situation, major disaster, or major epidemic occurs in the country of an international student, and educational institutions in the region become unable to operate normally as a result, that student's admission to senior secondary school or junior college may be given special consideration on a case by case basis, if details of those circumstances have been assessed and submitted by an R.O.C. overseas mission or by the embassy, consular


